# 8 Policies Sites and Places update-prior to discussing consultation next month

Prior to the Parish Council meeting Cllr Hope provided the following notes to Councillors.

#### THE SOUTH GLOUCESTERSHIRE LOCAL PLAN

As a result of a Planning Appeal at Charfield, where the Inspector found the Planning Authority (SGC) does not have a 5 year land supply for housing development – which leaves its Local Plan vulnerable to speculative development, the Planning Authority has done further work on its Local Plan.

The Council needs to take steps to ensure more homes are built in South Gloucestershire over the next 5 years that meet people's needs. This is in order to meet Government policy that requires the Council has sufficient housing land supply for the next 5 years.

Currently the shortfall over the next 5 years is around 1,500 dwellings. The Policy Sites & Places Plan cannot be submitted to government as previously envisaged while this shortfall remains, therefore the consultation document sets out the process by which the Council will aim to address it. Reasons as to why this shortfall has arisen are set out in the consultation document.

The objective is to make housing allocations that will support sustainable development and which can genuinely be built over the next 5 years to meet the growing demand. To achieve this, the Council needs to identify sites over and above those allocations in the Core Strategy, including within the rural areas.

#### Consultation

The Council has prepared a consultation document which sets out the methodology proposed to consider locations and sites suitable and available for allocation in the

Plan. It contains a number of questions and a response form is available to assist people in replying. A 'Call for Sites' report has been released, which listed all sites previously presented for consideration. The document clearly states that the inclusion of the submitted sites within the schedule does not imply that the council supports the site for development.

The consultation document, together with all the necessary forms are available to download on the Council consultation webpage at <a href="https://www.southglos.gov.uk/PSPconsultation">www.southglos.gov.uk/PSPconsultation</a>, including a number of other supporting documents and the paper on Policy PSP38 which form part of the consultation.

# **Local Green Space Designation**

For information regarding Local Green Space Designation (LGS), an update is now available on the Council's website at <a href="https://www.southglos.gov.uk/lgsd15">www.southglos.gov.uk/lgsd15</a>. Additional engagement with newly identified landowners and leaseholders is due to begin shortly.

In addition Cllr Robinson received an email regarding the Tennis Club, requesting clarification as to why the Parish Council had not included the whole area under the LGS designation. This was done deliberately to protect the Tennis/Cricket club; excluding the Club House and Tennis Courts would ensure that if they wished to extend in the future they would be able to do so. Protecting this area would prevent any redevelopment. Cllr Robinson will respond to this email. **To be actioned**

#### 11 Former Resident application update

A response to the Parish Council letter has been received from Kim Mylchreest HomeChoice Services Manager

They were unable to discuss the details of any housing applicant without their permission and so could not comment in relation to the individual.

The PC asked for information to help the understanding of how and when local connections lettings criteria are applied;

Criteria which restricts lettings to those with a local connections to a village or parish is something that is usually established at the time of planning approval, based on evidenced need, and is not set by HomeChoice. This would include where there is a restriction on bidding to those with a local connection to a particular village.

Any properties that the Council has nomination rights to must be let in accordance with its published rehousing policy which sets out how properties will be let and includes any restrictions on who can bid as established under the planning process.

In the absence of any restrictions, any applicant on the Housing Register is able to bid for suitable properties as they are advertised. To apply criteria that do not comply with its planning or rehousing policies is not something that HomeChoice is able to do.

In order for this to be changed, this would require a variation that can only be

achieved through the proper processes within the Council, for example remitting the matter back to members for their decision to amend a planning approval retrospectively. Again, this would be on the grounds of evidenced need. At the moment Kim is not aware that this is intended for any scheme.

In relation to Hawkesbury Upton, there are three social landlords who have stock within the village – Knightstone, English Rural and Merlin Housing Society. Of these, Knightstone and English Rural properties do have a restriction on local connection to the village and Merlin's do not.

The individual concerned has now moved up the list, it was agreed for the Clerk to write to Kim to find out the process to change their criteria to stay in line with Knightstone and English Rural.
