10 Highways Verges and Dog bins

Mr J Ionides contacted the Clerk to explain he cuts the grass verge outside Pool house approx 45m by 1m and will continue to do so. He will need a licence to continue.

It was requested the Clerk contact Mr Michael Dixon from South Gloucestershire Council to see how much SGCC would charge to cut the small piece on the ring road.

Sandpits Lane, sloping verges in front of the houses cutting and blowing required when obtaining quotes. It would be nice to use someone locally.

As above Mr Ionides will continue to do his bit outside Pool House, Mr Jones has written in to offer his service on grass cutting. Therefore confirmation from SGCC regarding specific areas is needed.

The Parish Councillors agreed not to cut the grass verges by the church more than twice a year this falls within the new specification from SGCC. Tenders required for the remaining areas shown on the map once confirmation has been received. No tender to be given to SGCC at the moment.

With regards to the Parish Council's existing dog bins, these can be converted to ordinary litter bins; one bin outside the Fox (next to the Phone box) to be moved by SGCC free of charge to the end of Bath Lane, by the Pool, the dog bin in Birgage to be converted to a litter bin.

- Miniature fruit tree request. A request has been received by the Clerk from Mr Hull asking if it would be possible to plant some dwarf (standard) fruit trees. They are aware that in the contract it states no trees are to be planted on the site but would like the parish council to consider their request.

The Parish Council discussed this item in full and agreed for dwarf fruit trees to be planted as long as they did not cause any shading to other allotments and no more than 6ft at maturity would be acceptable. All in favour.
